PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL

PRODUCT FOR WEED CONTROL IN PINEAPPLES

PERMIT NUMBER – PER81856

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Products to be used: EZYCROP DIURON 900 WG HERBICIDE (APVMA No. 91688) PLUS OTHER REGISTERED PRODUCTS Containing: 900 g/kg DIURON as the only active constituent.

4FARMERS DIURON 500 SC LIQUID HERBICIDE (APVMA No. 56349) PLUS OTHER REGISTERED PRODUCTS Containing: 500 g/L DIURON as the only active constituent

Directions for Use:

Critical Use Comments:

The label restraint prohibiting use on slopes above 3% does not apply to use under this permit. The application of diuron to pineapple plantations is not restricted by the slope of the property and may occur on properties regardless of their slope.

- Apply via boom sprayer to pineapple crops after planting and before weed emergence.
- To prevent phytotoxicity, apply Diuron before fruit differentiation or flower bud formation. It is recommended to apply in a minimum water volume of 2,000 L/ha.
- After flower bud formation, treat inter-row spaces only.
- For Ratoon crops, apply immediately prior to the first rains on weed free soil. Use water volume of 1,000 L/ha.
- DO NOT apply more than once per calendar year.
- DO NOT apply more than 1.8 kg diuron/ha per 12 month period. Equipment calibration is essential to ensure accurate delivery.
- DO NOT apply with spray droplets smaller than ULTRA-COARSE spray droplet size category.
- DO NOT apply by air.
- DO NOT use in water-logged areas.
- DO NOT apply if greater than 50 mm rainfall is expected within one (1) day of application.
- DO NOT irrigate within 3 days of application.
- DO NOT use on very light sandy or gravelly soils as crop damage may occur.

Re-planting Restrictions:

- Diuron treated areas can be replanted to pineapple or sugarcane one (1) year after spray application.
- DO NOT replant treated areas with other crops within two (2) years of application of diuron, except when otherwise stated on label.

MANDATORY BUFFER ZONES

DO NOT apply if there are aquatic and wetland areas including aquacultural ponds, surface streams and rivers within 30 metres downwind from the application area.

DO NOT apply if there are sensitive crops, gardens, landscaping vegetation, protected native vegetation or protected animal habitat within 75 metres downwind from the application area.

Timing restrictions for broadcast application:

Region	Spray timing restrictions
Cape York	DO NOT spray during November
Northern Gulf	DO NOT spray during November
Mackay Whitsunday	DO NOT spray from October to end of December

No timing restrictions are required for the Wet Tropics, Burdekin, Fitzroy, Mary/Burnett, SE Queensland, Condamine / Culgoa, Border Rivers or Balonne production horticulture regions.

Timing restrictions for inter-row application:

Region	Spray timing restrictions
Cape York	DO NOT spray during November
Northern Gulf	DO NOT spray during November
Mackay Whitsunday	DO NOT spray during October and November

No timing restrictions are required for the Wet Tropics, Burdekin, Fitzroy, Mary/Burnett, SE Queensland, Condamine/Culgoa, Border Rivers or Balonne production horticulture regions.

Harvest: Not required when used as directed.

Jurisdiction:

QLD and NT only.

Unless otherwise stated, the use of the product must be in accordance with the product label.
